MARKETABLE PHOSPHATE ROCK AUGUST 2019

U.S. marketable phosphate rock production in August was 2.13 million metric tons (Mt), which was 9% higher than that in July and 15% lower than that in August 2018. Total production for January through August was 15.4 Mt, which was 16% lower than that in the same period of 2018 (table 1).

Phosphate rock sold or used in the United States in August was 2.05 Mt, which was 6% higher than that in July and slightly higher than that in August 2018. Total phosphate rock sold or used for January through August was 15.6 Mt, which was slightly higher than that in the same period of 2018. U.S. producer stocks were slightly higher than those at the end of July and 11% lower than those at the end of August 2018 (table 1).

Imports of phosphate rock in August were 100,000 metric tons, which was 63% lower than those in July and 71% lower

than those in August 2018. Imports of phosphate rock during January through August were 24% lower than those in the same period of 2018 (table 2). Imports of phosphate rock can vary substantially from month to month based on sales contracts and production schedules of the phosphate plants.

Estimated apparent consumption, based on annualized data, for 2019, was 25.7 Mt, compared with 26.4 Mt in 2018 (table 3).
