# TIN

Tin has not been mined in the United States since 1993; thus, the United States is reliant on imports and recycling for its tin needs. In 2016, the amount of primary tin metal consumed domestically was 22,500 metric tons (t) worth an estimated \$416 million. Approximately 11,300 t was recovered from the consumption of domestic scrap. Industry stocks were 10% less than those at yearend 2015 (tables 1, 5).

World tin mine production was 288,000 t, a 16% decrease from the revised production total in 2015 (table 9). Of the 18 countries in which tin was mined, 6 countries accounted for 90% of the total production. China was the leading producer (32% of world output), followed by Burma (19%), Indonesia (18%), Brazil (9%), Peru (7%), and Bolivia (6%). World primary tin smelter production was 306,000 t (table 10), a 7% decrease from the revised total of 2015. According to CRU International Ltd., world refined tin consumption for 2016 was 346,000 t, a slight increase from the previous year (CRU Tin Monitor, 2018).

The annual average New York dealer price for Grade A tin in 2016 was 11% more than that in 2015 at \$8.39 per pound, and the annual average London Metal Exchange Ltd. (LME) cash price was \$8.15 per pound, 12% more than that in 2015 (table 1). World tin reserves were estimated to be 4.8 million metric tons, about 16 times the estimated 2016 world primary tin production. The majority of tin reserves were in Asia and South America.

#### Legislation and Government Programs

*Conflict Minerals.*—The U.S. Securities and Exchange Commission was responsible for implementing Section 1502 of the Dodd-Frank Wall Street Reform and Consumer Protection Act, which is related to the use of minerals determined to be financing conflict in Congo (Kinshasa) or an adjoining country. Cassiterite, one of two principal minerals mined for tin, was included in the list of "conflict minerals," defined as cassiterite, columbite-tantalite, gold, wolframite, or their derivatives. Section 1502 required companies for which conflict minerals or their derivatives were necessary to the functionality or manufacture of their products to disclose annually whether any of those minerals originated in Congo (Kinshasa) or an adjoining country (U.S. Securities and Exchange Commission, 2012, p. 56274–56275).

In 2016, 1,230 companies filed conflict minerals disclosures for 2015 (1,281 companies filed disclosures in 2015 for 2014). The ability of reporting companies to identify the country of origin of conflict minerals was hindered when there were multiple tiers of suppliers between the reporting company and the upstream concentrate-processing facility. After conducting due diligence on the source and chain of custody of the conflict minerals in their products, an estimated 55% of the companies reported that they could not confirm the source of the conflict minerals and about 99% reported that they could not determine whether the minerals financed or benefited armed groups. Although reporting companies were not required to identify which conflict minerals they used, of those that did, 61% reported using tin. Tin concentrate production from Congo (Kinshasa) and adjoining countries has only been 2% to 4% of world production in the past 5 years (table 9) (U.S. Government Accountability Office, 2017, p. 3–7).

#### Production

Tin has not been mined in the United States since 1993, when it was mined in Alaska. In 2016, tin recovered from new and old scrap was estimated to be 11,300 t, slightly more than that of 2015 (table 5). A significant quantity of alloy tin scrap was generated during manufacturing processes and recycled within those same industries (new scrap).

Secondary tin recovered from obsolete fabricated parts (old scrap) was used in many types of products and was a particularly important source of tin for the manufacture of brass, bronze, and solder. In 2016, 10,300 t of tin was recovered from old scrap, with 8,540 t from lead-base scrap and 1,740 t from directly melted copper-base scrap at brass mills, ingot makers, and foundries (table 5).

#### Consumption

Tin in the United States was used, in descending order by weight, in chemicals, 21%; tinplate, 18%; solder, 17%; alloys, 10%; babbitt, bronze or brass, and tinning, 9%; and other, 24% (table 3). Tin-based chemicals are commonly used in polyvinyl chloride (PVC) production and curing, biocides, and catalysts. Tinplate is a layer of tin adhered to steel or wrought iron substrate for corrosion protection. Tin is used in this case to inhibit rust and is commonly used in food-grade cans. Tin alloys are used in brass and bronze products, solders, and lowfriction metals. Solder is commonly used in electronic devices for connections on circuit boards.

In 2016, U.S. reported tin consumption was 22,500 t of primary tin and 2,920 t of secondary tin. Domestic consumption data for tin were developed by the U.S. Geological Survey from a voluntary survey of tin consumers. Of the 116 firms to which a survey form was sent, 56 responded, accounting for 48% of estimated reported consumption. Data for the nonrespondents were estimated based on prior-year reporting.

#### Prices

The Platts Metals Week annual average New York dealer price for Grade A tin metal was \$8.39 per pound in 2016, 11% more than that in 2015. The LME remained the principal commodity exchange for trading tin and in 2016, the annual average LME cash price for tin was \$8.15 per pound, an increase of 12% from the 2015 average LME price of \$7.29 per pound (table 1).

#### **Foreign Trade**

U.S. imports for consumption of refined tin, which supplied most domestic tin requirements, totaled 32,200 t in 2016, 4% less than those of 2015 (table 8). Imports of tin in all forms (metal, ore and concentrate, scrap, and waste) remained duty free. Foreign-owned trading firms operating in the United States tended to dominate the marketing of imports. United States imports of tin came from Indonesia (27%), Malaysia (23%), Peru (20%), Bolivia (19%), Brazil (7%), and other countries (4%). Refined tin exports in 2016 were 1,150 t, about a 340-t increase from 2015 (table 6).

#### World Review

According to a survey by the International Tin Association Ltd. (formerly International Tin Research Association Ltd.), the world's 10 leading refined tin producers and their production in 2016 were, in descending order of production, Yunnan Tin Group Co. Ltd. (China), 76,000 t; Malaysia Smelting Corp. Bhd. (Malaysia), 26,802 t; PT Timah (Persero) tbk. (Indonesia), 23,756 t; Yunnan Chengfeng Co. Ltd. (China), 20,100 t; Minsur S.A. (Peru), 19,573 t; Empresa Metalúrgica Vinto S.A. (Bolivia), 13,038 t; Thailand Smelting and Refining Co. Ltd. (Thailand), 11,088 t; Guangxi China Tin Group Co. Ltd. (China), 10,984 t; Metallo Chimique International N.V. (Belgium), 8,541 t; and Gejiu Zi-Li Mining and Smelting Co. Ltd. (China), 8,200 t; (International Tin Association Ltd., 2017b).

*Australia.*—In August, AusTin Mining Ltd. recommenced production at the Granville tin processing plant in Tasmania. The plant initially retreated the existing tailings at the site and then began processing stockpiled ore later in the year. AusTin Mining was also in the process of obtaining the necessary regulatory approval for an expansion project at Granville, which included resuming mining at the site and increasing tin-inconcentrate production to about 550 metric tons per year (t/yr) (AusTin Mining Ltd., 2016).

On December 13, the Federal Court of Australia rejected the merger proposal between Kasbah Resources Ltd. and Asian Mineral Resources Ltd. The merger had the approval of the Kasbah board of directors and 90% of the shareholders, but the minority shareholders objected, citing an error in the valuation of their shares. The court ordered Kasbah to pay the minority shareholders reasonable costs, including at least 50% of the previous court hearing costs. Kasbah Resources owned the Achmmach deposit in Morocco, which has been projected to produce up to 7,000 t/yr (Garvey, 2016). When the merger failed, Pala Investments Ltd. purchased a 19.9% stake in Kasbah for \$2.7 million (3.23 million Australian dollars), allowing Pala Investments to appoint two representatives to the Kasbah board (Pala Investments Ltd., 2016).

**Brazil.**—Brasil Manganês Corporation Mineração S.A. (BMC) (a subsidiary of Meridian Mining S.E.) signed an agreement with Cooperativa de Garimpeiros de Santa Cruz Ltda. and Cooperativa Metalúrgica de Rondônia Ltda. to reprocess tailings from the Bom Futuro Mine in the Ariquemes District, Rondonia State. BMC also gained the first right of refusal on either the acquisition of the mineral rights or the provision of underground mining services in the area and could secure up to 80% of the unexplored area surrounding the mines (Metal-Pages, 2016b). Minsur announced that the Pitinga Mine produced 6,875 t of tin in concentrate in 2016, a 20% increase from 5,744 t in 2015 and the highest level of production since the company acquired the mine in 2008. Minsur attributed the production increase to the completion of several debottlenecking projects and repairing the hydroelectric power unit at the mine. All concentrates were sent to the company's Pirapora refinery in Sao Paulo, which produced 5,873 t of refined tin in 2016, 6% more than that in 2015 (Minsur S.A., 2017a, p. 8, 42; 2017b).

*Burma.*—Burma accounted for most of China's tin concentrate imports in 2016, supplying 472,506 t of tin ore and concentrates containing an estimated 57,000 t of tin. Approximately 18% of this was believed to be from Wa County government stocks. Burma's ore continued to be produced predominantly in Wa County, or Wa Special Region 2 in northern Shan State, close to the border with China (International Tin Association Ltd., 2017a).

*China.*—In January, nine of China's tin producers agreed to cut production by a combined 17,000 t for the year, citing low prices. Participants in this production cut included Yunnan Tin, China Tin, and Chengfeng. The total tin production of all participating companies was around 140,000 t, equivalent to 80% of China's tin production, or 40% of global tin production in 2015 (International Tin Association Ltd., 2016a).

In July, tin smelters in Guangxi Zhuang Autonomous Region and Jiangxi and Yunnan Provinces suspended or scaled back production, reportedly for Government-mandated special environmental inspections. Inspection teams were sent to eight Provinces where most of the country's nonferrous metals production took place, and inspections were mostly completed by the end of August. Smelters gradually built their production levels back up to previous levels when the inspections had been successfully completed. In September, only four smelters remained closed, which represented 18% of China's annual refined tin production (International Tin Association Ltd., 2016b, c).

*Indonesia.*—In February, PT Refined Bangka Tin closed its smelting and refining facility and stopped tin production, citing low tin prices and stringent environmental regulations. The company announced that the refinery would be dismantled and the site would be turned into a conservation area. PT Refined Bangka Tin typically exported about 5,000 t/yr of tin (Metal-Pages Ltd., 2016).

According to the results of an audit carried out by Indonesia's Ministry of Energy and Mineral Resources, only 29 out of 47 tin smelters in the Bangka-Belitung Islands Province were operating in 2015. The tin smelting capacity utilization rate in the Province, which accounted for approximately 90% of Indonesia's tin production, was only around 20%. The audit also showed that of the 755 companies that held a license to operate, only 498 had a "clean and clear" certification. The "clean and clear" certification had been required since November 1, 2015 (International Tin Association Ltd., 2015, 2016d; Metal-Pages, 2016a).

#### Outlook

World tin reserves appeared to be adequate to meet shortterm demand. Secondary sources of tin are likely to become an increasingly important component of supply, especially in the United States. Domestic tin requirements are expected to continue to be met primarily through imports.
